### General Volunteer Opportunities

#### Ticket and Money Collection Station

Job description- The volunteer will be standing while collecting money and giving out a ticket to individuals entering the park to participate in pioneer days. The volunteer needs to be able to make change and be comfortable with exchanging money.

#### Kettle Corn Station

Job description- The volunteer will be bagging kettle corn. Requires some standing and the ability to scoop corn into a bag.

#### Candle Dipping Station

Job description- The volunteer will collect money and give out a wick to those who want to make a candle. The volunteer will also assist with melting wax and must be comfortable around a coleman stove.

#### Wagon Ride Money Collection

Job description- The volunteer will collect money from those wanting to go on a wagon ride. The volunteer needs to be able to make change and be comfortable with exchanging money.

#### Tin Punch Station

Job description- The volunteer will tape a pattern on a piece of tin and then give it to the participant. This is a loud station due to the hammering.

#### Ham and Bean Station

Job description- The volunteer will distribute bowls and corn bread to participants that want ham and beans.
