

# BLUHM COUNTY PARK

Located just north of Westville, this park was established in 1992 and consists of 96 acres donated by Gayle and Lucille Bluhm. The park boasts a healthy wildflower population in both woodland and restored prairie habitat. Bluhm offers over 8 miles of multiple use trails including hiking, biking, mountain biking, horse and cross-country skiing. It also has a bark park, picnicking, shelter rental and a playground.



## NO-LEASH Dog Exercise Area

Daily or annual permit is required for each dog present. Permits are available on site.

## PARK HOURS

7 am to Sunset

We hope you enjoy Bluhm County Park.

Please observe the following rules:

- **Alcoholic beverages are not allowed**
- **All pets must be on a leash when outside of the no-leash area**
- **Do not release any wildlife**
- **No fireworks allowed**
- **No ice fishing or cross country skiing on bodies of water**
- Vehicles allowed in parking area only
- Bicycles must yield to pedestrians and horses
- Off-road vehicles are not permitted
- Do not collect or destroy any plant or animal life
- Picnic only in designated areas
- Charcoal fires are permitted in grills – wood fires are **not** permitted
- No overnight camping
- Boating and swimming are not allowed
- Persons between 18-70 yrs. of age must have a valid Indiana Fishing License to fish Bluhm Pond
- Paint balls are not permitted
- No metal detectors allowed
- NO HUNTING or TRAPPING!
- **Park closes at sunset**

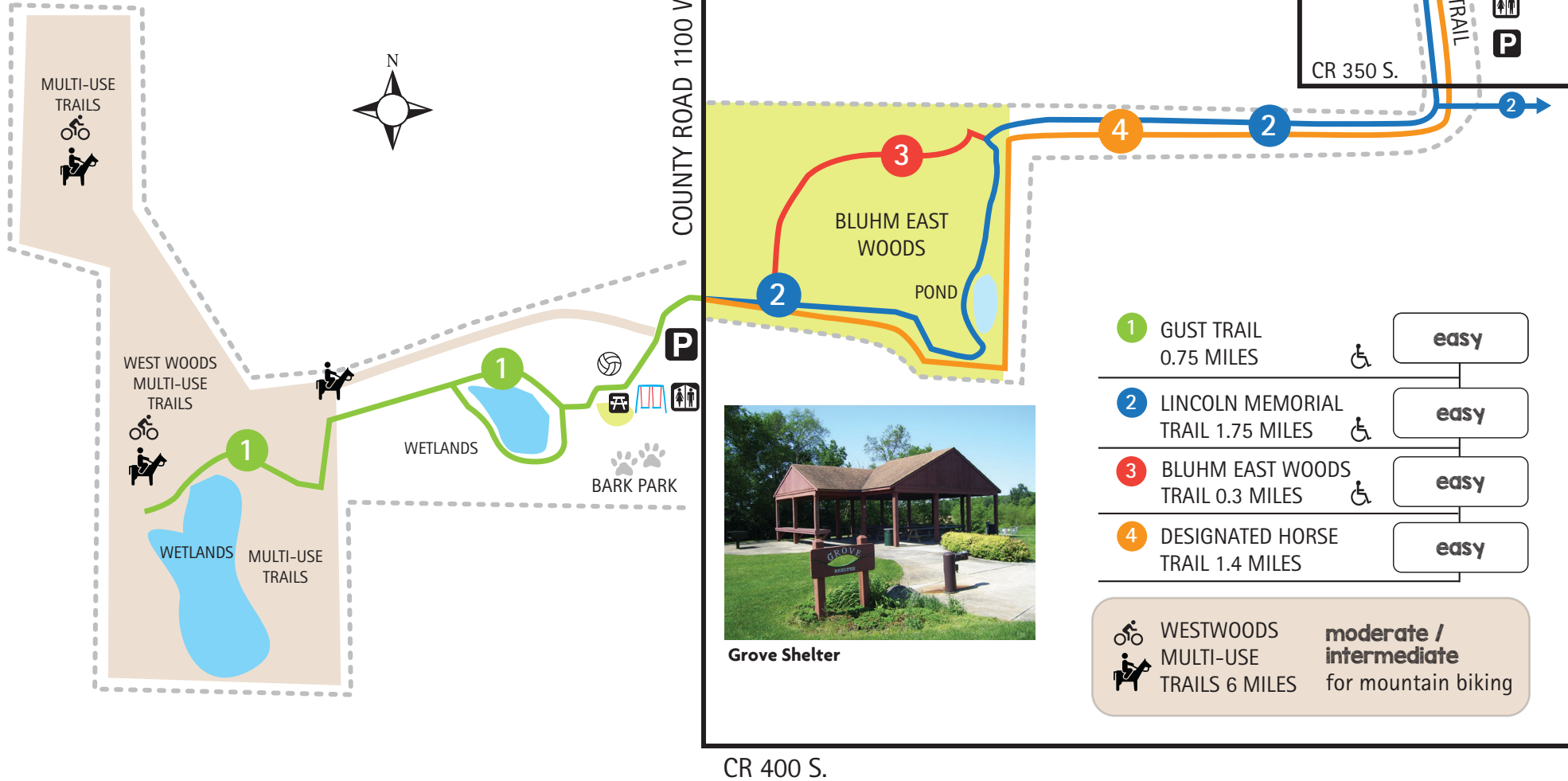
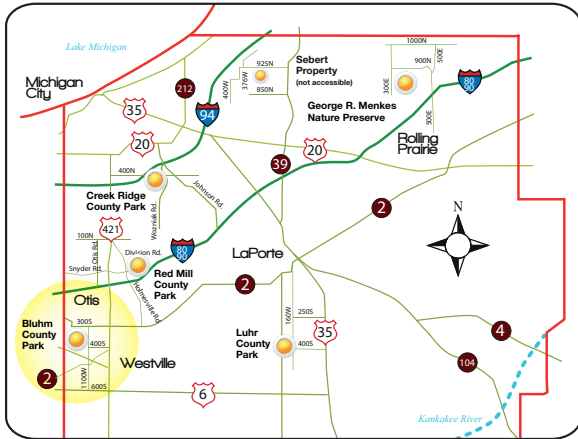
