

# CREEK RIDGE COUNTY PARK

Established in 1992, this park encompasses 112 acres much of which was donated by Aubrey and Judith Greenberg to the Department of Natural Resources and is leased to the County. The main natural feature at Creek Ridge is Trail Creek which hosts an annual migration of steelhead and salmon from Lake Michigan. The developed portion of the park offers picnicking, shelter rentals, a dog park, 9-hole disc golf course, Bring your own bag toss games, volleyball, hiking trails and fishing access along 4,000 feet of Trail Creek!

Our most popular activities at Creek Ridge are picnicking and our no leash dog park. Visitors both human and canine come from miles away to visit this park daily. While you are here, be sure to take a hike down the Steelheaders Boardwalk to see if the trout or salmon are running!

## NO-LEASH Dog Exercise Area

Daily or annual permit is required for each dog present. Permits are available on site.

Good times to see migrating steelhead and salmon are February-March and late September-October.

We hope you enjoy Creek Ridge Park.  
Please observe the following rules:

- **Alcoholic beverages are not allowed**
- **All pets must be on a leash except in No-Leash Dog Park**
- **Do not release any wildlife**
- **No fireworks allowed**
- Vehicles allowed in parking area only
- Bicycles must yield to pedestrians
- Off-road vehicles are not permitted
- Do not collect or destroy any plant or animal life
- Picnic only in designated areas
- Charcoal fires are permitted in grills – wood fires are **not** permitted
- No overnight camping
- Boating and swimming are not allowed
- Persons between 18-70 yrs. of age must have a valid Indiana Fishing License, and an Indiana trout/salmon stamp, to fish Trail Creek
- Paint balls are not permitted
- No metal detectors allowed
- NO HUNTING or TRAPPING!
- **Park closes at sunset**

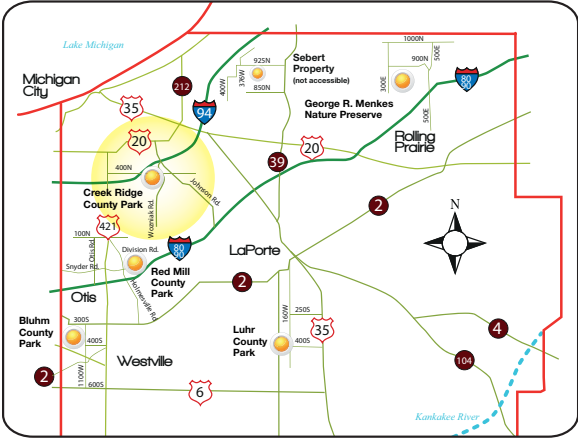




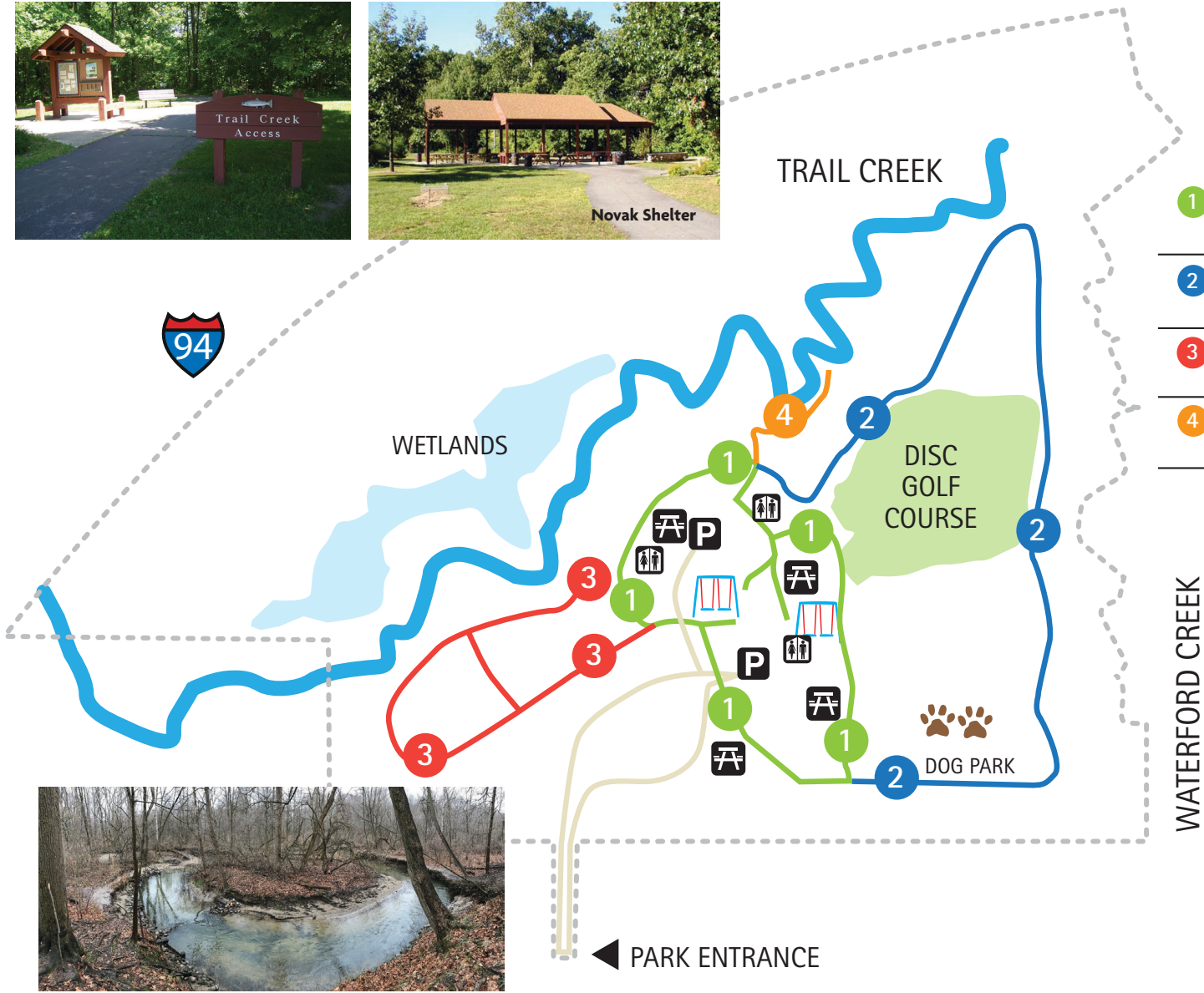
