SEBERT WOODS COUNTY PARK

This property consists of just under 40 acres west of Highway 39 on county road 925 North. Sebert Woods is a boreal forest relic. The property contains plants and habitat you would normally see much farther north. Due to its proximity to Lake Michigan, the wet sandy soils, past land disturbance and cooler weather have allowed this property to retain some of the plant species and habitat you will enjoy while visiting. This property was donated to the La Porte County Park Foundation by Wilmer Sebert in 2000. In 2021 the property was dedicated as a State Nature Preserve due to the unique and special habitat and plants present. Due to the sensitivity and uniqueness of this property the only planned development are the trail and parking area.

We hope you enjoy Sebert Woods County Park.


