LaPorte County Park Board Meeting August 1, 2023 Minutes

I. CALL TO ORDER

II. ROLL CALL

- Present: All present
- Guests: ALCO TV, Joe Haney, Dan Masena, Earl Cunningham, Members of the "Pickle Ball Club"

III. PLEDGE OF ALLEGIANCE

IV. APPROVAL OF AGENDA

- Ron made a suggestion to move the public comment to the sixth thing on the agenda so the Pickle Ball Club could make their comments then instead of having to sit through the whole meeting.
- Mary Nell made a motion to change the agenda, seconded by Mary. Motion carried 7-0.

V. APPROVAL OF MINUTES

- No changes or additions to the minutes from last meeting.
- Mary made a motion to approve the minutes as written, seconded by Jim. Motion passed 7-0.

VI. PUBLIC COMMENT

- Dan Masena from a group of pickle ball players, informed the Board of the growing popularity of pickle ball. They are in need of a facility at which to play. They have used the YMCA facility, but desire an outdoor facility.
- Earl Cunningham, County Councilman, also from the pickle ball group, presented a request to the Park Board to install a pickle board court at one of the County Parks, specifically Creek Ridge.
- Pickle ball requires an asphalt base. Four pickle ball courts can fit in the space of one tennis court. Courts should run north and south to avoid looking into the sun.
- Pickle ball is a noisy sport, and the pickle ball club thinks Creek Ridge is an ideal location due to the thick tree barrier between the park and the residential area.
- They suggest a possible collaboration between the La Porte County Parks and Michigan City Parks.
- Earl also pointed out that the Parks have lots of programs and equipment geared toward young people and children (new playgrounds), but not much for older adults, which accounts for the majority of pickle ball players.
- Estimated cost would be approximately \$160,000 for four courts. Ongoing costs for maintenance and upkeep is relatively minimal. Asphalt lasts over ten years.

- Following discussion and questions, it was suggested that the Planning Committee partner with the pickle ball people to get more details.
- Mary Nell made a motion for the Planning Committee to get together with Jeremy and look further into pickle ball, seconded by Erin. Motion passed 7-0.
- Earl Cunningham added that if anyone wanted to get together with him and watch a pickle ball game, see Jeremy for his phone number.
- Joe Haney also made a public comment: Mentioned the positive feedback the parks got from a visitor to Luhr park, said that the Park Dept. is doing a great job and keep up the good work.

 Motion passed 7-0.
